Instructions

1. Leak must be fixed prior to application submission.
2. Purchase/service date must be prior to April 30, 2024 to qualify.
3. Proof of the repair must be included. Accepted proof can take the form of:
 - Invoice from a plumber or other certified professional. Service must specify a leak repair
 - Copy of sales receipt including all parts purchased for the repair and photos of the fixed area.
 - Before/after copies of utility or water meter alert (*Only use if water provider or water meter has leak-detection capabilities*)
4. A copy of the sales receipt is to be attached to this application. Accepted proof of sale can be an invoice from a plumber, or *all* parts purchased to fix the leak.
5. Tenants must submit an owner-authorized letter.

Terms and Limitations:

1. Gallatin River Task Force staff or agents may contact applicant by phone or in writing to verify information provided for in the application.
2. Only applicants with installation addresses within the Big Sky Resort Tax Area District are eligible to participate in the Big Sky Water Conservation Program and receive any rebates.
3. Rebate applications must include proof of purchase. This can be in the form of a receipt from the retailer, or invoice from installation. Receipt must include date and itemized items/services.
4. Rebate applications must include proof of fix. This can be in the form of photos and receipts from retailers, invoice from a plumber, or copies of water meter or provider alerts (*only applicable to meters and provider platforms that offer leak detection*).
5. The rebate amount is only eligible to complete applications. One application per household.
6. The leak fixed must be at the installation address listed on website.
7. The effective date of the Big Sky Water Conservation Program is July 1, 2016 and this rebate is only available until April 30, 2024. Any services or purchases made outside of these dates will not be considered for rebate.
8. Applications will be processed in the order they are received.
9. Incomplete applications could be denied and returned to applicant or result in a delay of rebate approval
10. Limited funding is available to issue rebates. Rebates will be issued on a first-come, first-serve basis, subject to funding availability.
11. A rebate check will be mailed within 6-8 weeks of receipt provided the application is complete and funding is available.
12. All rebate participants will automatically receive one monthly email update from the Task Force. You can unsubscribe from this service at any time and we will never share your personal information with a third party.
